On *Monday March 7* our walk will be to see one of Melbourne's icons – the Brighton Bathing Boxes. At 10.30 am we will meet on the corner of Dendy Street and Sussex Street, Brighton (Melway 76 D1). Parking is available in Dendy Street (between Sussex Street and New Street) and in Sussex Street. <u>Please be aware of the parking signs</u>.

From our_meeting point we will walk to the Esplanade and cross at the Dendy Street traffic lights before making our way to the beach.
